## **Birla Corporation Ltd. (Birla Corp)**



- Birla Corp is flagship company of M.P.Birla Group. Incorporated as Birla Jute Manufacturing in the year 1919, it was the Late Chairman Shri Madhav Prasad Birla who gave shape to its present form
- Birla Corp has products which include cement, jute goods, PVC floor covering, auto trims etc.
- Cement division has seven plants having installed annual capacity of 5.8 million tonnes. Cement units have been receiving awards for productivity, pollution control, energy performance and worker's education









## **Birla Corporation Ltd. (Birla Corp)**



- Jute division produces a variety of jute products which covers major applications of jute and is supplied globally
- Auto Trim division has Technology Collaboration with Empe-Werke, Germany to manufacture natural fibre based interiors for use in cars
- Vinoleum division was set-up in the year 1991 under technical collaboration with Congoleum Corporation of USA and manufactures Cushion Vinyl Flooring and PVC sheets
- Birla Corp is a listed company in the National Stock Exchange and Bombay Stock Exchange











### **Hindustan Gum & Chemicals Ltd.**



- Hindustan Gum is largest manufacturer of Guar Gum in the world with its brand name "HIGUM" a hallmark of quality and innovation
- The company was established in collaboration with Stein Hall of USA (now Rhodia Inc.)
- Hindustan Gum has since been premium manufacturer of Guar Gum, Guar Gum Powder, Cationic Gum and Textile Thickener which is being supplied globally
- The products cater to a diverse range of industries, such as food products, textile, papers, explosives, oil drilling, mining etc.
- Hindustan Gum has an annual capacity to manufacture 31,000
   MT of powder gum and 32,000 MT for refined splits









#### Universal Cables Ltd. (Universal)



- In the year 1962 Shri M.P.Birla established Universal to manufacture paper insulated cables.
- In the year 1977, collaborating with M/s Asea Kables AB, Sweden (now ABB) Universal brought XLPE technology to India. Over the years Universal had several other collaborations, all with internationally acclaimed leaders in their respective fields.



- The Capacitor Division was set up in the year 1967, and since then has progressed having collaborations with Toshiba, Japan and General Electric, USA for variety of products.
- Universal has recently introduced VCV Technology, in technical collaboration with Furukawa Electric Co., Japan to manufacture EHV cables in the range of 220 kV to 400 kV.
- Universal has also tied up with VISCAS Corporation, Japan (Power cable alliance between Fujikura and Furukawa) for new generation cable jointing accessories for voltage grade upto 400kV.

- Over the years, Universal has received many accolades, including National Safety Award from Govt. of India
- Universal is a listed company in National Stock Exchange and Bombay Stock Exchange








## Vindhya Telelinks Ltd. (Vindhya)



- Vindhya was established as joint sector between Universal and Madhya Pradesh State Industrial Development Corporation Limited to manufacture jelly filled telephone cables
- Vindhya was set-up in Technical Collaboration with Ericsson Cables AB, Sweden and started commercial production in the year 1986
- Installed capacity of JFTC is today at 7.48 million CKM annually.
- Optical Fibre cables by installing a complete new state-of-the-art plant during the year 1998. Over the years









### Vindhya Telelinks Ltd. (Vindhya)



- Vindhya has become one of the leading suppliers of telecommunication cables to BSNL, MTNL, Bharti, Reliance, Tata, Railways etc.
- Vindhya has recently added EPC division which is taking up turnkey projects in the fields of telecommunication and power infrastructure.
- Vindhya is a listed company in the National Stock Exchange and Bombay Stock Exchange











#### Birla Ericsson Optical Ltd. (Birla Ericsson)



- Birla Ericsson was set up as a Joint Venture company between the M.P.Birla Group companies and Ericsson Cables AB, Sweden (now called Ericsson Network Technologies) to manufacture Optical Fibre Cables In the year 1992
- Birla Ericsson today has one of the widest manufacturing capabilities in India for OFC to produce complete range of products including High Fibre Count Ribbon Cable
- Birla Ericsson also manufactures JFTC and special copper cables









### Birla Ericsson Optical Ltd. (Birla Ericsson)



- Birla Ericsson has an agreement with M/s AFL Telecommunications for sale of hi-tech overhead OFC, specially OPGW and associated accessories, which find applications with electric power utilities etc.
- Birla Ericsson is looking at expanding further, with FTTx as one of the prominent field.



- Over the years, Birla Ericsson has established itself as a premium brand for telecommunication cables in India.
- Birla Ericsson is a listed company in the National Stock Exchange and the Bombay Stock Exchange







## **Optic Fibre Goa**





- Optic Fibre Goa was established as a joint venture between Universal, Vindhya and Birla Ericsson in the year 2001 with primary objective of manufacturing Optical Fibres
- Plant is located at Goa a south western coastal state of India
- The plant was commissioned for commercial production in the year 2002
- Since then, Optic Fibre Goa has been able to carve out a market in India and is successful in getting approvals from prominent Indian Telecom Service providers such as BSNL, Bharti, Reliance, Idea etc.
- Optic Fibre Goa, as a company, was amalgamated into Universal Cables Limited with effect from 1st April 2005
