# **Security Forces nab 3 hardcore** Ultras from Katekalyan area


DANTEWADA, Jan 7

INYET another crackdown on Naxals, the Security Forces succeeded in nabbing three hardcore ultras including two wanted cadres from Katekalyan area in insurgency hit district on Saturday.

As per police sources, the arrested rebels have been identified as Vetti Varsa alias Fagnu, Masa alias Kumma Madwi and Panda alias Nanda Madwi. The action was taken by a composite team comprising personnel of Katekalyan police and Central Reserve Police Force (CRPF), 195th Battalion.

"The composite team was out as part of its anti-naxal operation, when it received a tip-off about the presence of red rebels at somewhere in Katekalyan police limits. Acting upon tip-off the Security personnel reached the indicated spot where they saw a suspicious person trying to escape. After a brief





chase, he was nabbed," informed the police sources, adding that two other Ultras were held by a joint team of Dantewada Police and District Reserve Group, small action team.

During interrogation, they identified themselves as Jan Militia commander, Vetti Varsa alias Fagnu, Local Operating Squad member, Masa alias Kumma Madwi and Jantana Sarkar Committee member, Panda alias Nanda Madwi.

"These insurgents were involved in various acts of violence including attacks, blast, arson and various

needed for the balance of power in the world, Adhin in his address said India can once again become a 'Vishwa guru'.

He said India can become a superpower and had the potential to become a spiritual and cultural hub. Adhin also urged the youth diaspora to work for

mutual benefits while recognising thier strength of enterprise and entrepreneurship. Goel called on the youth diaspora to give suggestions on channelising their force and help in creating infrastructure for it. He also assured of all possible assistance from his Ministry for those willing to take up social projects in any part of the country.

About 300-400 overseas Indian youth are participating in the Youth PBD, including nearly 150 PIOs who are visiting India for the Know India programme.

The Youth PBD in 2017 includes plenary sessions on problems faced by Indian students abroad, problems faced by NRI students in India. and startups and innovation which have a social impact in India. The Youth PBD 2017, with focus on 'Redefining engagement with the Indian Diaspora', is being attended by delegates from 72 countries and registration has crossed 7,200 as of yesterday, officials said.

The event being held on the city outskirts aims to provide a platform to overseas Indians to engage with the Government on issues of concern to the diaspora and to explore opportunities for investment in India and contribution to the country of their origin.

The convention, being held biennially for the first time instead of earlier annual versions, will aim at redefining India's engagement with its 3.12 crore strong diaspora in diverse spheres, including innovation, start-ups, tourism and education. According to organisers, a total of 6,346 registrations have been confirmed for PBD 2017 and more than 1,500 NRIs and 400 floating NRIs will be a part of the event. Prime Minister Narendra Modi will deliver the keynote address on Sunday, when the Indian origin Prime Minister of Portugal Antonio Costa will he the Chief Guest at the even

Launched by the Vajpayee Government in 2003 as an annual event to step up India's engagement with its diaspora and the congregation of NRIs and Persons of India origins, the Government decided to make PBD a biennial event last year. January 9 is the main day of PBD as it was on this day in 1915 that Mahatma Gandhi, the "greatest Pravasi", returned to India from South Africa and led India's freedom struggle.

CARDS, ATMS, POS WILL BE REDUNDANT BY 2020 IN INDIA: KANT: AMID the big push being given to digital transactions post-demonetisation, NITI Aayog CEO Amitabh Kant on Saturday said cards, ATMs and POS machines would become redundant in the country by 2020.

...India is in the midst of huge huge disruption in the world of both financial technology and in terms of social innovation (there is) huge huge innovation and this disruption will enable India to leapfrog...," he said.
"...And by 2020 my view is that in the next two-

and-a-half years, India will make all its debit cards, credit cards, all ATM machines all POS machines totally irrelevant," Kant told a session at Pravasi Bharatiya Divas 2017, a three-day mega event of Indian diaspora.

He said, "They will all become redundant in India, and India will make this jump because every Indian will be doing his transaction just by using his thumb in thirty seconds....'

Speaking at a session on 'Startups and innovations which have social impact in India' at the Youth Pravasi Bharatiya Divas here, he said, "What we are pushing now is digital payment in a very big way and it is a huge disruption with several innovative methods.

Euro 30 million (about Rs 225 crore) from M/s AgustaWestland which was nothing but "kickbacks" paid by the firm to execute the deal for sale of 12 helicopters to India in favour of the firm in "guise" of genuine transactions for performing multiple work contracts in the country.

James is one of the three alleged middlemen being probed in the case, apart from Guido Haschke and Carlo Gerosa, by ED and CBI. Both the agencies have also notified an Interpol Red Corner Notice (RCN) or the global arrest warrant against James after a court had earlier also issued an NBW against him.

The present complaint delved into the alleged detailed role of James in the deal, his multiple visits to India and his transactions. The first complaint in the case was filed in November 2014.

According to sources, ED has already sought James' extradition from the UK. In the this complaint, the agency has also claimed that the three middlemen "managed" to make inroads into the Indian Air Force in order to influence and subvert the stand of the force regarding reducing the service ceiling -- the altitude at which a helicopter can fly — from 6,000 metres to 4,500 metres in 2005 after which AgustaWestland became eligible to supply the choppers for VVIP flying duties. It said that remittances made by James through his Dubai- based firm Ms Global Services, FZE to a media firm he floated in Delhi, along with two Indians, were made from the funds which he got from Ms AgustaWestland SpA through "criminal activity" and corruption being done in the chopper deal that led to the subsequent generation of proceeds of crime. Former IAF chief S P Tyagi was granted bail on December 26 last year while his cousin Sanjeev Tyagi and lawyer Gautam Khaitan were granted the relief on January 4 by the court in a separate case filed by CBI in connection to the same deal. The agency had arrested all the three accused on Dec 9 last year.

### EC seeks Centre's response...

The Cabinet Committee on Parliamentary Affairs had recently recommended that the Budget session will commence on January 31 and the Union Budget will be presented on February 1 so that the new provisions come into force from April 1, the beginning of the new fiscal. "When the opposition had objected in 2012 during the Assembly polls to these five States, Congress had accepted their stand and postponed presentation of the Union Budget from February 28 to March 16. We want that there should be no presentation of the Budget till the elections are over," Leader of the Opposition in Rajya Sabha and Congress leader Ghulam Nabi Azad had said after meeting EC on January 5. Azad said electoral laws make it clear that the ruling party should have no advantage during elections and both the Opposition and the ruling side should be on an equal footing.

He said the Budget on February 1 will tilt the balance in favour of BJP as it would use the exercise to influence voters by doling out sops. Finance Minister Arun Jaitley has defended the move asking why the Opposition parties are afraid of it when they have claimed that demonetisation is an unpopular decision.
