Nature and details of the action(s) taken, initiated or order(s) passed;	<p>The European Commission vide its Implementing Regulation (EU) 2025/1135 has imposed a definitive Countervailing Duty (CVD) on imports of optical fibre cables originating in India and amending Implementing Regulation (EU) 2024/3014 imposing a definitive anti-dumping duty on imports of optical fibre cables originating in India effective from 12th June, 2025 at 00:00 Hrs.</p> <p>The CVD of 5.40% of CIF Union border price shall be imposed on the exports of single mode optical fibre cables [made up of one or more individually sheathed fibres, with protective casing, whether or not containing electric conductors, whether or not connectorized, currently classified under CN code ex 8544 70 00 (TARIC codes 8544 70 00 10 and 8544 70 00 91)], by the Company to European Union.</p> <p>The anti-dumping duty which was earlier determined @ 6.90% of CIF Union border price on the exports of single mode optical fibre cables under TARIC additional code 89CF has now been reduced to 2.90% based upon the representation and submissions made by the Company.</p> <p>Accordingly, the combined CVD and anti-dumping duty of 8.30% shall be imposed on the exports of single mode optical fibre cables by the Company to European Union.</p>
